**for General Councillor (representing Clinical Science) of the European Pancreatic Club  
(EPC)**

### MINIMUM REQUIREMENTS - ELIGIBILITY

- The applicant needs to be member of the EPC when the application is submitted
- The applicant needs to be member of the EPC for at least 5 years
- Good command of spoken and written English
- Personal commitment and adequate time resources for volunteer work
- The applicant has to be an internationally recognized clinician
- The applicant needs to have at least 5 original/review papers in international journals (listed in PubMed) in the field of clinical science in pancreatology
- The applicant needs to be available for two council meetings a year for 3 years

### TERMS OF OFFICE

- The councillor will be elected for 3 years (from the end of the annual meeting of EPC 2014 – until the end of the annual meeting of EPC 2017)
- Second term is not possible

### SUBMITTING APPLICATIONS

The application has to be addressed to the Secretary of the EPC and must be written in English.

The applications must include:

- completed application form (can be downloaded from <http://e-p-c.org/open-calls>)
- CV and list of main publications (full articles only) (maximum of 3 pages)
- Mission statement (maximum of 1 page)

Applications will be filed and tagged by the Secretary of the EPC. Should the application prove deficient, the Applicant shall be notified by e-mail within five working days. The Applicant should then eliminate the deficiency revealed within another five working days.

Submission deadline for the application: 1<sup>st</sup> May, 2014

Eligibility will be checked by the Council. Elections are performed at the General Assembly in the forthcoming EPC meeting in Southampton according to the rules stipulated in Article V in the statutes of the EPC.

## Mission Statement, Council Member-Clinical Science, Enrique de-Madaria

Since I started my career as a clinical pancreatologist in 2005, I become *engaged* to the EPC. This European association of multidisciplinary clinical pancreatologists as well as basic investigators in pancreatic physiology and diseases represents a perfect forum for sharing knowledge and research.

As a clinical science council member I would promote three major issues:

1. **European multicenter studies in pancreatic diseases.** I would suggest creating working groups covering the main pancreatic diseases, each of them with a formal structure: an experienced coordinator and a specific group gathering (open to any investigator interested in each particular field) in the EPC meeting. The aim of the working groups would be to propose, design and coordinate multicenter trials within the EPC.
2. **The development of EPC clinical guidelines in pancreatic diseases.** Guidelines are major tools for clinicians. I would suggest working together to develop guidelines that will help professionals to deal with diseases of the pancreas and will increase the EPC visibility in the clinical community. We have leading international clinical investigators in most pancreatic disorders to perform these projects.
3. **To make the EPC attractive to young clinicians.** Together with the Pancreas 2000 and Youppie initiatives, I would promote educational projects aimed at young clinicians interested in the pancreas: e-learning courses (I would try to get involved the UEG and its e-learning platform) and text books/handbooks focused in frequent clinical problems. The recruitment of tomorrow's pancreatologists will be an important task for the future of the EPC in my opinion. New members should feel (as Dr Neoptolemos felt when he attended his first EPC meeting, according to his speech after his life-time achievement award) "*I want to be part of this*".
